Since this is the first newsletter, it may be appropriate to introduce the Local Government Services Division of the Department of Taxation and offer a brief overview of each section.

Local Government Services Division (LGS) is split into six specialized sections as follows:

Audit Section has eight employees that work diligently on the Net Proceeds of Minerals tax filings. Bonnie Duke is the Supervisor of the section and provides guidance and advice on laws, procedures and desk reviews as well as digging in depth into the books and records of the mines to ensure accurate and concise reports. Boards & Commissions has four employees who are very proficient at keeping agendas, meeting minutes, paperwork and records for Nevada Tax Commission,

Centrally Assessed Section has seven employees led by Supervisor Sorin Popa. This section is responsible for valuing Centrally Assessed properties such as railroads, telecoms, electrics, gas pipelines and airlines as well as appraisal and net proceeds of approximately 148 mines and geothermal sites across the State of Nevada.
