## **TAXATION REVENUE STATISTICS – February 2020**

### **Taxable Sales by County**

The Nevada Department of Taxation released statewide taxable sales for February 2020, which total \$4,786,059,766. That represents a 4.9 percent increase over February 2019. Fourteen of Nevada's 17 counties recorded increases.

### Monthly Excise Tax Revenue Collections – February 2020

Monthly excise tax collections totaled \$34,101,733 in February, while the Commerce Tax (due annually) took in \$448,705 during the month. Seven of these tax types have seen increased revenue this fiscal year versus the prior fiscal year.
