Summary

The matter of the Taxpayer's petition for review of property valuations for the 2012-13 Secured Roll within Washoe County, Nevada, came before the State Board of Equalization (State Board) for hearing in Carson City, Nevada, on May 16, 2012 after due notice to the Taxpayer and the Assessor.

At the hearing on May 16, 2012, the Assessor proposed to settle the matter and offered a stipulated agreement for approval by the State Board based on the decision of the State Board in case 11-217. See Tr. 5-16-12, p. 63, II. 20-25. The State Board moved to approve the stipulated agreement proposed by the parties. See Tr., 5-16-12, p. 64, II. 1-12.

DECISION

The State Board, having considered all evidence, documents and testimony, hereby approves the taxable values proposed by the parties for the subject property, case number 12-273.

The Washoe County Comptroller is instructed to correct the assessment roll by adjusting the assessed valuation of the subject property as follows:
