## NOTICE OF DECISION

#### Summary

The matter of the Taxpayer's petition for review of property valuations for the 2013-2014 Unsecured Roll within Washoe County, Nevada, came before the State Board of Equalization (State Board) for hearing in Carson City, Nevada, on October 9, 2014 after due notice to the Taxpayer and the Assessor.

At the hearing on October 9, 2014, the Assessor proposed to settle the matter and presented a stipulated agreement for approval by the State Board. See Tr. 10-9-14, p. 175, l. 17 through p. 178, l. 6. The State Board moved to approve the stipulated agreement proposed by the parties. See Tr., 10-9-14, p. 178, ll. 10-24.

#### DECISION

The State Board, having considered all evidence, documents and testimony, hereby approves the taxable values proposed by the parties for the subject properties in case numbers 14-319, 14-320, 14-321, 14-322, 14-323, 14-324, 14-325, 14-326, and 14-327.

The Washoe County Comptroller is instructed to correct the assessment roll by adjusting the assessed valuation of the subject property as follows:
