NOTICE OF DECISION

Summary

The matter of the Taxpayer's petition for review of property valuations for the 2015-16 Secured Roll within Clark County, Nevada, came before the State Board of Equalization (State Board) for hearing in Las Vegas, Nevada, on June 1, 2015 after due notice to the Taxpayer and the Assessor.

The State Board, having considered all evidence, documents and testimony pertaining to the valuation of the property in accordance with NRS 361.227, hereby makes the following Findings of Fact, Conclusions of Law and Decision.

FINDINGS OF FACT

- 1) The State Board is an administrative body created pursuant to NRS 361.375.
- 2) The State Board is mandated to hear all appeals of property tax assessments pursuant to NRS 361.360 and NRS 361.400.

- The Taxpayer and the Assessor were given adequate, proper and legal notice of the time and place of the hearing before the State Board, and the matter was properly noticed pursuant to the Open Meeting Law at NRS 241.020. The Department provided evidence to show the Taxpayer received notice of the hearing. See Record, SBE page 45.
- The subject property is a 6 story, Class A office building constructed in 2009, shell finish. The improvements contain 177,427 square feet situated on a 7.96 net acre site, located along Grand Montecito Parkway, north of the Beltway and south of Rome Boulevard in the far NW Valley, Clark County, Nevada. See Record, SBE page 31; Maps, pages 35-37; Tr., 6-1-15, p. 267, II. 4-18.
- 5) The Clark County Board of Equalization (County Board) ordered the total taxable value for the subject property of \$17,491,262 be upheld for the 2015-2016 secured roll. See Record, SBE pages 13 and 43.
- The State Board found the Taxpayer did not present sufficient evidence to support values different from that established by the County Board. The State Board considered whether a greater deduction for the sales price of tenant improvements ("TI") should be taken, but determined that even with a greater deduction of \$75 per square foot for TI, it could not overcome the income indicator of value established by the Assessor. The State Board found the taxable value established by the Assessor was well supported. See Tr., 6-1-15, p. 276, I. 2 through p. 278, I. 7.
- 7) The State Board affirmed the decision of the County Board. See Tr., 6-1-15, p. 278, l. 16 through p. 279, l. 18.
- 8) Any finding of fact above construed to constitute a conclusion of law is adopted as such to the same extent as if originally so denominated.

CONCLUSIONS OF LAW

- 1) The Taxpayer timely filed a notice of appeal, and the State Board accepted jurisdiction to determine this matter.
- 2) The Taxpayer and the Assessor are subject to the jurisdiction of the State Board.
- 3) The State Board has the authority to determine the taxable values in the State.
- 4) The subject property is appraised at the proper taxable value as previously determined by the County Board in accordance with NRS 361.227 for the 2015-2016 tax year. The assessed value is 35% of taxable value.
- 5) Any conclusion of law above construed to constitute a finding of fact is adopted as such to the same extent as if originally so denominated.

DECISION

The Petition of the Taxpayer is denied based on the above Findings of Fact and Conclusions of Law. The Clark County Comptroller is instructed to certify the assessment roll of the county consistent with this decision.
