Summary

The matter of the Taxpayer's direct appeal petition of its business personal property audit came before the State Board of Equalization ("State Board") for hearing in Las Vegas, Nevada on June 15, 2017, after due notice to the Taxpayer and the Department. See Record, SBE at 60-62. The petition was brought pursuant to NRS 361.360(3) as a direct appeal because the personal property was placed on the unsecured tax roll after December 15th.

At the hearing, the Assessor proposed to settle the matter and presented a stipulated agreement for review and approval by the State Board. The State Board approved the stipulation for the subject property proposed by the parties. *Transcript 6-15-2017* at 130-131; *Record, SBE* at 64-65. The stipulation covered two separate Machine Zone, Inc. locations and the corresponding accounts for each location.

DECISION

The State Board, having considered all evidence, documents and testimony, hereby approves the taxable values proposed by the parties for the subject property, case number 17-166.

The Assessor is instructed to correct the assessment roll by adjusting the valuation of the subject property as follows:
