#### **INTRODUCTION**

The Top Ten Statewide list is limited to the blend of centrally-assessed and locally-assessed top ten lists as provided by the Centrally-Assessed Section of the Division of Excise and Local Government Services and local County Assessors. The reader should be aware of the possibility that a taxpayer might not appear on the Top Ten Statewide list because the taxpayer's assessed value in some counties was not listed in the top ten locally-assessed list. For example, Wal-Mart was listed on the Top Ten locally assessed lists in Churchill and Douglas Counties but the statewide total could not be calculated for the company because the company was not on the Top Ten list for Clark County.

Actual tax liabilities may not have a direct relationship to assessed value due to the "tax cap" pursuant to NRS 361.4722 through 4724. These values are based on County information received by the Department as of October 31, 2023.

It combined the mines, including plants and facilities, Goldstrike, Cortez, Turquoise Ridge, and Goldrush from Barrick, and Carlin, Twin Creeks, Phoenix, and Long Canyon from Newmont.
