#### ADMINISTRATION (ALAN)

- 1. Attended and successfully completed four required Advantage/Financial classes taught by the Controller's Office.
- 2. Attended CMR tour of Comstock Mining's operations and overview presentation.
- 3. Attended quarterly CMR meeting and subsequent Mackay awards banquet.
- 4. Provided information to Renaissance Gold on historic mine info and accessibility on NBMG's Mining District File Database.
- 5. Worked with Jill Jakobiak (Geotemps-Ely) to complete process for Jeff Herrera (Hergon Mine Securing) to continue with planned AML work in southern Nevada as a contractor for Geotemps.
- 6. Continued work on Annual Status and Production reports.

# AML / PUBLIC AWARENESS - NORTH (MIKE)

- 7. Met with Scott Jolcover and Randy Harris (Comstock Mining) to review sites for downhole camera surveys. Visited four sites and conducted survey of the New York shaft. Survey replicated as part of CMR tour later in the week. Copy of downhole survey video provided to Comstock Mining.
- 8. Peter and I met with Rick Darby (City of Sparks, Parks and Open Space) and conducted a site visit at their proposed Wedekind Regional Park. Provided closure guidance on three previously identified hazards and logged three additional hazards and 13 non-hazards.
- 9. Provided Debbie Struhsacker (Pershing Gold) with clip of AML database pertaining to their property positions east of Lovelock.
- 10. Provided Chris Ross (BLM-NSO) with current snapshot of AML database.
- 11. Revisit Burrus site and find headframe, all timbers, and 2 year-old PUF closure burned. Rachel, Pete and I fenced the now open shaft. EPS estimate for grate to cover the shaft and the unstable ground now covering the shaft is \$12,000. Combination of hard closure, PUF, and vents to be considered. Russ Fields (UNR-Mackay) will file report with Washoe County Sheriff's office.
- 12. Assemble and scan CRAC forms documenting securing work on BLM-managed lands during 2009, 2010, and 2011. Contractor Kate Schnoor collected additional data and assembled sets in binders for submission to the BLM.
- 13. Attended RAMS conference call with Pete, regarding potential money (up to \$1M) for AML closure projects throughout the west in FFY13.

- 14. Set up field reconnaissance of proposed bat gate site in Lyon County with Rachel Crews (archaeologist, BLM-CC).
- 15. Spoke with homeowner, Dan Bowers (Gold Hill), regarding using large shaft on his property as exercise for interns' logging and fencing class. He graciously agreed and allowed us to use his garage as a classroom when snowy weather arrived. Portions of the existing fence around the Alta shaft were repaired, while others sections were replaced.

Discuss AML program, policies, procedures, safety, etc. Mandatory classes on defensive driving, sexual harassment, archaeological resource recognition and safety were presented to and attended by the eight interns; Abijah Bauer, Eric Dougherty, Kelly Elloyan, Drew Jones, Orgil Norov, Kate Schnoor, Murya Dube (returnee) and Joey Winkler (returnee).
- 17. Conducted field reconnaissance visit with Eagle Scout candidate, Zac Newman, in Sparks.

- 1. Investigated a report of dynamite in an abandoned mine adit (LY-366) with a representative of the Mine Inspector's Office. Result was a false report.
- 2. Drove to Las Vegas and switched field vehicles with Bill Durbin. Drove back to Reno and investigated unsecured mines south of Tonopah on Lone Mountain.
- 3. Attended a field trip to Virginia City and toured the Comstock Mining Company's mine and exploration sites. Meeting was attended by representatives from the Commission on Mineral Resources and NDOM staff.
- 4. Attended the Commission on Mineral Resources quarterly meeting in Reno.
- 5. Attended the University of Nevada Reno's award ceremony for students, staff and mining professionals.
- 6. Met with Mike Visher and City of Sparks rep for a field visit to identify AML hazards in the Wedekind mining district and to discuss closure options and long-term plans.
- 7. V&T revisits, logging, and securing continued in the Virginia City area.
- 8. Sent out letter of request and follow-up with Steve Saylor of Comstock Mining about their AMLs, which were revisited by NDOM personnel.
- 9. Made a field trip to the Burrus Mine and found new vandalism (field visit with Mike and Rachel).
- 10. Met with JBR, NDOW, EPS, and Cindi Burns with Comstock Development on the evaluation and subsequent installation of bat-friendly enclosures in and around the Virginia City area.
- 11. Met with the owners (Hearst Family) of the Green Monster Mine complex in Clark County and discussed procedures for completing a PUF closure at 10 AML hazard sites.
- 12. Met with EPS personnel to fence the Vulcano mine (LY-994) due west of Silver City.
- 13. Called Mr. Allen Carter the owner of the Cherokee Mine in Lincoln County (LI-170-LI-173) to discuss the securing of hazards located on his patented property.
- 14. With the interns, I completed revisits and repair work at several AML hazard sites near Sand Mountain just east of Fallon.
- 15. Attended a conference call for RAMS discussing allocation of a small amount of Federal money designated for AML closures in western states (primarily in New Mexico).
- 16. Worked with Mike, Rachel, and the interns repairing a fence enclosure at the Alta Mine in Virginia City.

- 17. Met with the new group of eight UNR summer interns. Began training in field procedures, state regulations, vehicle inspection and maintenance, AML program summary, and various safety issues. Assisted Mike and Rachel with teaching the interns about the use and completion of all required forms with proper field documentation and the distribution of field equipment. Helped with GPS training and topographic location.
- 18. Completed the Archeological Site Recognition and Avoidance Course with a field visit to the Como mining district for field applications with Rachel of the BLM and the interns.
- 19. Completed first half of the State's Drivers' Education Course and the Sexual Harassment class along with the new summer interns. The remaining portion of the driver's education class will be completed online as required to obtain the proper certification.
- 20. Conducted a presentation with Rachel at the 2<sup>nd</sup> grade class of Mrs. Woodhead at Florence-Drake elementary school. Thirty eight students and two teachers in attendance.

# AML / GIS (RACHEL)

- 1. Spoke with several claimants regarding securing abandoned mine land hazards and how best to secure the sites. Sent additional information including maps and photos to claimants so that they may begin securing work.
- 2. Spoke with personnel at Newmont regarding unsecured sites on BLM land and sent additional information. They will begin working towards securing sites on claims in the coming months.
- 3. Received securing information from claimants and updated our database to reflect changes.
- 4. Updated the database with work received from Brian completed during the week of April 30<sup>th</sup>. Murya Dube added non hazards and revisit information to the database.
- 5. Traveled to the Burrus Mine with Mike Visher and Peter Herrera to check on the status of the securing work completed during the first week of May. Found that some of the sites had fallen victim to vandalism and were no longer secured. Secured WA-88 with a t-post and barbed wire fence.
- 6. Prepared and finished printing maps for the summer interns. The first week will be spent in the office and at nearby field locations while the second and third weeks will be spent in Lovelock and northwest of Beatty respectively with NDOM staff.
- 7. Traveled to areas east of Fallon to check on the status of secured hazards in the area with Peter Herrera. Several sites were found that will need securing. These locations east of Sand Mountain will be used in training exercises with the Summer Interns during the week of May 21. Collected several buckets of granite for the upcoming Reno Teachers workshop from the Project Shoal Site.
- 8. Received some questions from Newmont regarding NDOM logged hazards on Newmont claims. Researched the information and sent Newmont the existing NDOM ID numbers.
- 9. Received closure information for securing work that had been completed by the BOR in Northern Nevada. Began updating our database with the new securing information.
- 10. Prepared the maps for the week of May 29<sup>th</sup> for the interns. This will be the second training week and first full week in the field for the interns.
- 11. Spent the week training and going over job duties with the new group of Summer Interns. Traveled to the Como area with the interns to go over archeological training with Rachel Cruz from the Carson City BLM office.

- 12. Traveled to the Sand Mountain area with the summer interns and conducted several revisits. Time was spent teaching the interns the proper way to fill out revisit, new logging and non-hazard forms. Time was also spent learning the best ways to repair fences and secure hazards. The best and safest practices for driving large vehicles off road were also discussed.
- 13. Secured a large, unlogged shaft in the Gold Hill area with the Summer Interns. Logging and securing procedures were discussed during this time.
- 14. Attended Farm Days with Linda Carrion-Wells, Valerie Kneefel and George Bishop. Presentations were made to ~800 students the first day and ~900 students on the second day for a total of 1700 students. They ranged in age from 3 (preschool) to 13 (middle school students). Several homeschooled children were in attendance as well as students from the Reno area and Lake Tahoe area. A total of approximately 114 presentations were made to 15 students each (114 presentations – 1700 people).
- 15. Traveled to Florence Drake Elementary School with Peter Herrera to present rocks and minerals along with AML to second grade students. A total of 2 presentations were made to 24 students each (2 presentations 48 people).

- 6. AML reconnaissance visit to the Searchlight area with Chris Ross and Las Vegas BLM staffers Shonna Dooman and Suzanne Rowe to locate and evaluate AML sites proposed for future permanent closure. Prepared and sent an AML notification letter to Nevada Outdoor School/Andy Hart for the Arden Mine hazards.
- 7. AML field investigations of a room and pillar gypsum mine near Logandale with Chris Ross and BLM staff from the Las Vegas Field Office. The sites have been logged by NDOM – securing options appear to include only fencing as there is little available dump material and dozer access is minimal. There are over 30 mine openings – several potential Eagle Scout securing projects.
- 8. Logged one Clark County non-hazard.
- 9. Received notification from Ely BLM about a mine shaft that has opened up and partly engulfed the access road to the Ward Mine. The site is WP-569. It was logged in 2007 as a 3' by 5' by 10' deep shaft ranked moderate. It was re-visited by NDOM in 2009. The collar stayed about the same dimensions but was observed at 40-50' deep hazard ranking upped to high. The shaft was posted with signs during both visits. The shaft is on patented land and the owner has been notified. BLM has put up posts with flagging.
- 10. Conducted AML claim research for Clark, Esmeralda and Nye County hazards.
- 11. Phone conversation with John Hayes, managing partner of the Coyote and Red Bird mines north of Searchlight regarding mine hazard closure plans. The Las Vegas office has provided him with a GIS map showing the locations of NDOM-logged hazards.

- 12. Met with Krynn Williams and Temple Mullen of Clark County Real Property Management, Leslie Nielsen of the Clark County District Attorney's office and Mike Shannon of Clark County Administrative Services regarding the mining claim situation and other issues relating to closure of the Arden Mine AML hazards – follow-up to discussions held at the last CMR meeting.
- 13. Investigation and completion of incident report following discovery of a "hit and run" on the Las Vegas agency vehicle while parked in the office complex parking lot. Damage was sustained to the two passenger side doors and rocker panel below. Obtained three repair estimates from local body shops paperwork submitted to AGs office and Risk Management.

- 2. Participated in the Commission on Mineral Resources quarterly meeting on Friday, May 4th. The meeting was held at Joe Crowley Student Union Building at UNR. Afterwards, attended the Mackay School of Earth Sciences and Engineering banquet. NDOM received the Special Friend of Mackay Award.
- 3. Met with Jeff Schwarz (Business Manager), Jon Ekstrom (Public Relations), of Noble Energy, and Trent Sizemore of Lone Wolf.
- 4. Attended Sage Grouse Committee meeting. The committee was formed by Governor Sandoval to study the economic impacts the regulations related to sage grouse habitat will have on rural counties, as well as ways to work with this issue. Bob Budd, appointed by Wyoming Governor Jim Geringer in 2000 to lead their state's sage grouse task force, spoke to the committee as to how Wyoming has handled the sage grouse habitat situation. Wyoming and the BLM have utilized a plan where activity in sage grouse lek core areas is limited to 5% disturbance. The Wyoming 'plan' also includes enhancing habitat areas near where disturbance is to occur, where the impact to the core area is compensated by enhanced habitat in a nearby area.
- 5. Attended the Nevada Geothermal Council meeting. Jack McGinley, from NV Energy, spoke about electrical transmission issues, as well as power purchase agreements (NV Energy does not necessarily need any more green PPA's for the next three to five years).
