IMPORTANT:

Per Nevada Revised Statute (NRS 361.321), please report any construction which represents a net addition to your company's property as distinguished from an addition of property exempt from taxation, a replacement or repair.

Nevada Administrative Code (NAC 361.258) defines Construction Work in Progress (CWIP) as the total of the balances of work orders for plant, road and equipment including expenditures on research, development and demonstration projects for construction of facilities. Please report figures for work orders as defined above and not simply changes to the balance of Construction Work in Progress accounts.
