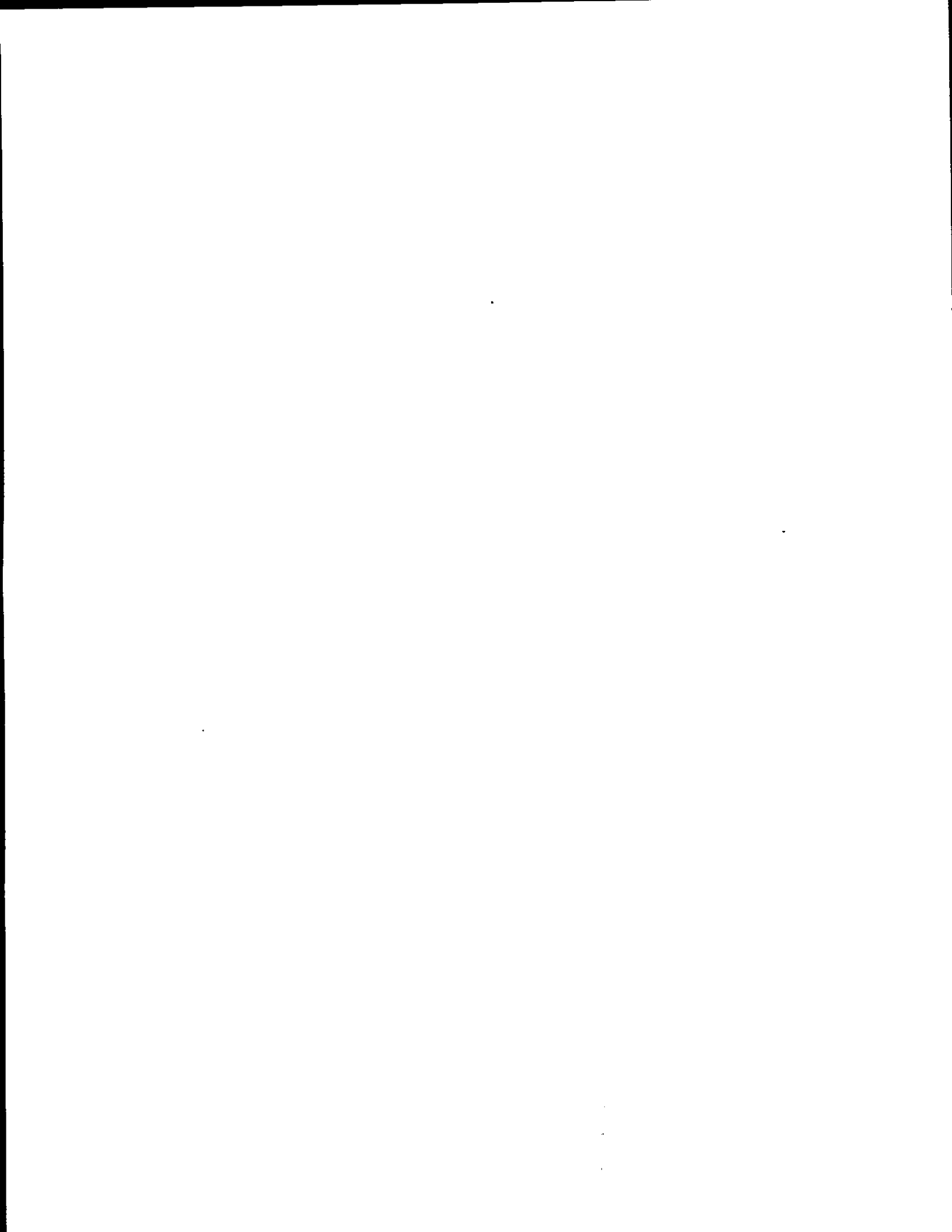

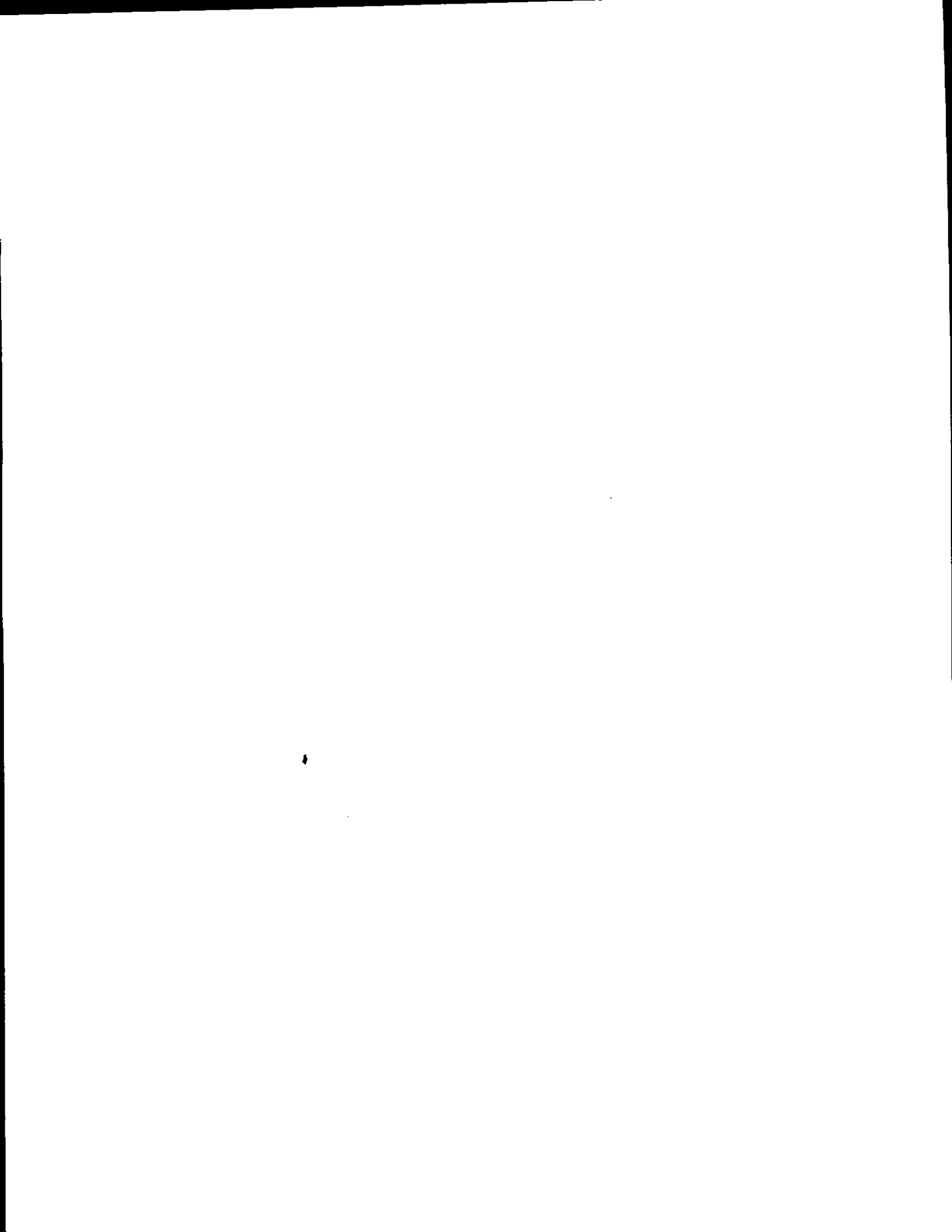

AD VALOREM TAX RATES FOR NEVADA LOCAL GOVERNMENTS FOR FISCAL YEAR 1968-69

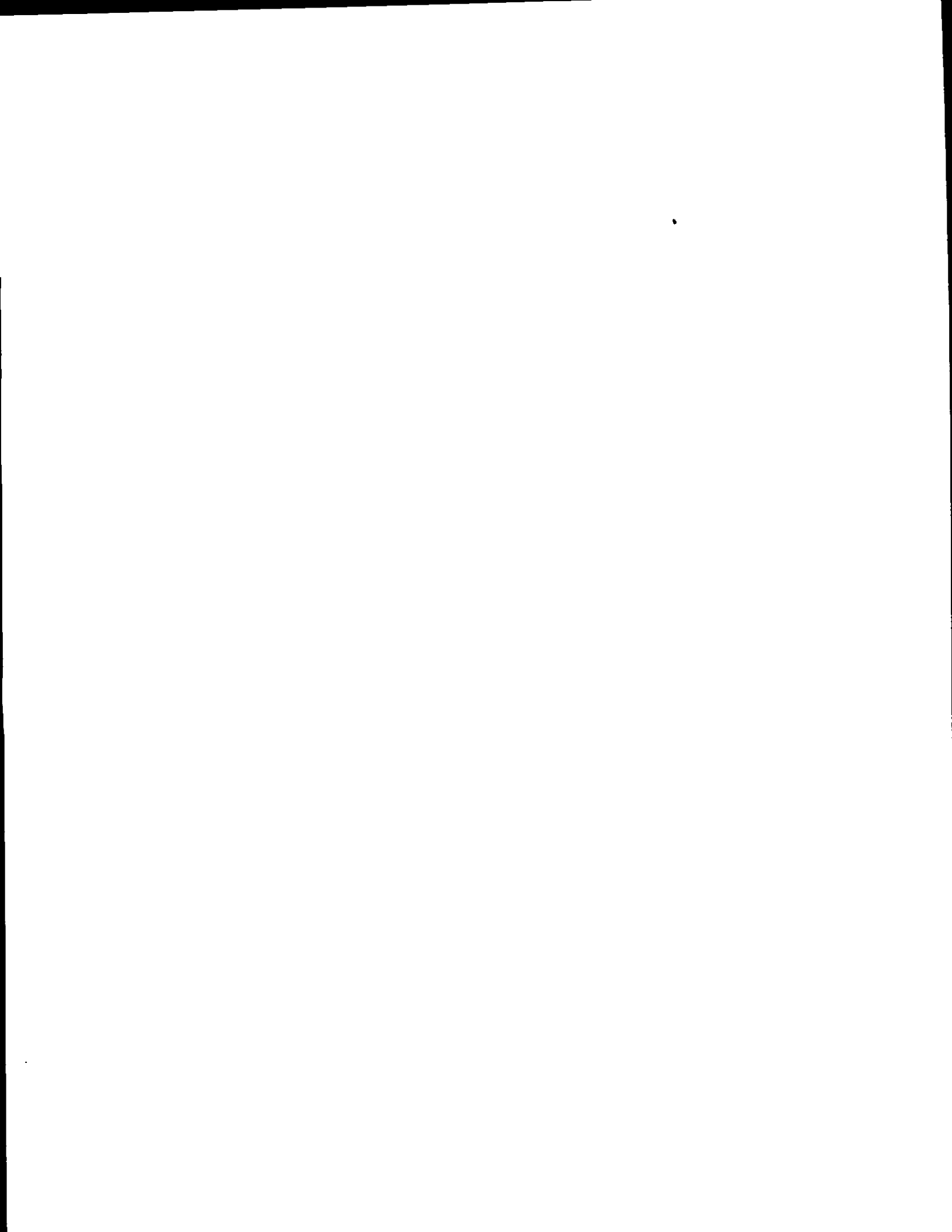

In addition, there are filed with the Tax Commission budgets from approximately 40 other local governments some of whom may levy or receive ad valorem taxes (See Part II).

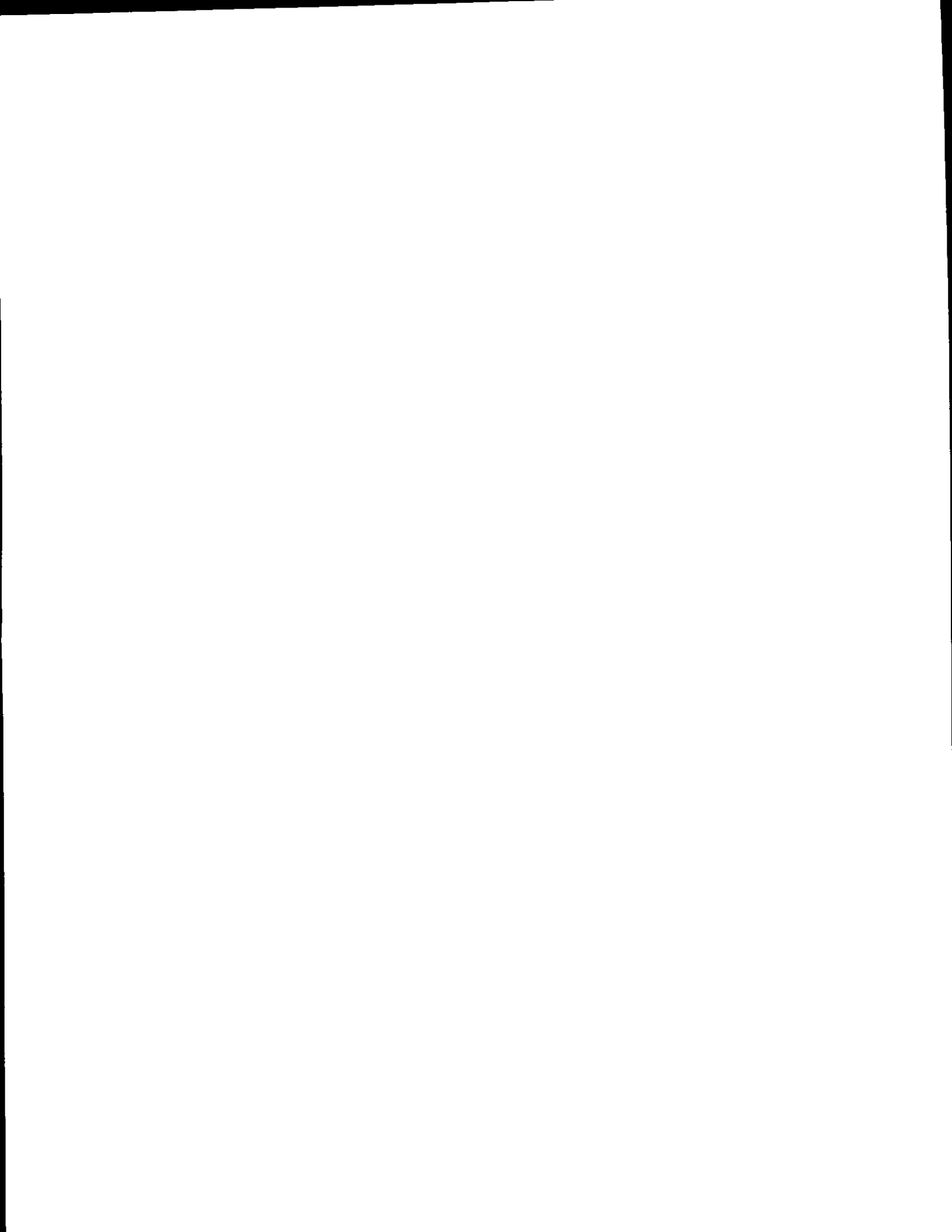
