**NOTICE OF INTENT TO ACCEPT APPLICATIONS FOR MARIJUANA LICENSES**

NOTICE IS HEREBY GIVEN that the Nevada Department of Taxation is seeking applications from qualified existing medical marijuana establishment certificate holders to apply for one or more recreational retail marijuana store license(s). Holders of medical marijuana cultivation, production and dispensary certificates may apply for one or more recreational retail marijuana store license(s).

Pursuant to LCB File No R092-17, the Department will accept applications for retail store licenses. The Department will be accepting applications for ten (10) business days.

**Application period opens: September 7, 2018, 8:00 AM**

**Application period closes: September 20, 2018, 5:00 PM**

The following establishments may apply:

- Existing Nevada medical marijuana establishments that hold a medical registration certificate(s).

All applicants are required to be in compliance with the following:

- All licenses, certificates, and fees are current and paid;
- Applicant is not delinquent in the payment of any tax administered by the Department or is not in default on payment required pursuant to a written agreement with the Department; or is not otherwise liable to the Department for the payment of money;
- No citations for illegal activity or criminal conduct; and
- Plans of correction are complete and on time, or are in progress within the required 10 business days.

Applicants should follow the instructions listed on the packet and include all the required supplemental forms. Completed applications must include:

- \$5,000 application fee, and
- The amount for the license fee:
  - \$20,000 for Retail Store
