This memorandum is written as a reminder that, pursuant to the requirements of NRS 354.59803, you are required to file a detailed report of the funds expended for activities designed to influence the passage or defeat of any legislation before the 2021 Nevada Legislature.

The statute requires this report to be submitted within 30 days following the closure of the legislative session; but **only if** the amount of the total expenditures for your lobbying efforts is in excess of \$6,000.

Please complete and submit the form to your budget analyst within the time frame specified in the NRS. Since the session ended on schedule, the report will need to be postmarked by July 2, 2021.
