- d) Review of cannabis matters relating to sovereign tribal interests and development of recommendations to support tribal interests in the cannabis economy.

- e) Review of cannabis consumption alternatives, not limited to, but possibly including consumption lounges. Development of recommendations regarding how the State and its subdivisions should proceed with such accommodations.
