Ms. Arambula stated that the Department is not able to do further collections on the other officers. One officer has submitted an offer-in-compromise which was approved.

D. 1) Trevett Williams: Chairman Wren asked if the Department is looking at the four partners for the remaining balance. Mixaly Arambula was present on behalf of the Department. Ms. Arambula stated that one of the partners is out of the question. The Department did have a personal lien for James Johnson, Jr. in October of 2009, and Wayne C. James in January of 2012. Unfortunately, due to system errors, the personal liens were not renewed. Commissioner Byram made a motion to approve the offer-in-compromise of Trevett Williams. Commissioner Johnson seconded the motion. All in favor. Motion carries.
