PUBLIC COMMENT FOR MARCH 29, 2022 CLGF MEETING

I ask that this statement be included in the minutes of this meeting.

My public comment is regarding item # 6 of the agenda, Review and Approval of Minutes from the November 9, 2021 CLGF meeting.

On page 4 of the draft meeting minutes, **ITEM 5 For Discussion and Possible action; hearing of appeal of advisory opinion to Mr. Neal Jones according to NAC 354.942.** This agenda item is related to the acquisition of property by Belmont, through NRS 361.603 and their lack of financial records.

- Nye County Assistant County Manager Lorina Dellinger is credited with the statement “They have a DA opinion that states it will be corrected to state transferred to the trustees of the area of Belmont since it is not a legal town.”
- Ms. Dellinger is not listed as being a member of the public present at the meeting.
- A public records request was submitted to Nye County for a copy of this DA opinion related to the properties Belmont owns.
- In their response to the public records request Nye County states “They have no records responsive to my request.” And “Nye County has no records responsive to this request. Any alteration of Resolution 2013-17 is yet to be prepared by the Nye County District Attorney’s Office.”
- At no time has the Nye County DA’s Office opined that Belmont is not a legal town.
- Please see attached public records request and response.

I request that the minutes of the November 9, 2021 meeting be amended to show that Ms. Dellinger was a member of the public present and that the record show that the statement by Ms. Dellinger to the Committee was not true.
