TAXATION REVENUE STATISTICS – August 2020

Taxable Sales by County

The Nevada Department of Taxation released statewide taxable sales for August 2020, which total \$4,877,175,697. That represents a decline of 9.9 percent from August 2019. Nine of Nevada’s seventeen counties recorded increases.
