There was a significant increase in complaints from taxpayers when registering and paying online, and there were some browser problems which have now been corrected. The Department has hired someone to correct these issues. Complaints have decreased.

The Department has a pre-session budget hearing this Wednesday, January 28, 2015. Director Contine will be including a budget summary to legislators. The Department is asking for someone that can help with economic forecasting. The Department will also be asking for a security person in IT. There have been mass breaches in security systems across the country.

Director Contine reported the Department has a cleanup bill; and a bill regarding the presumption on interstate commerce based on the Harrah's case. A Bill Draft Request has been submitted regarding reform of the Business License fee.
