## EXHIBITION FACILITY FEE INSTRUCTIONS ANNUAL FILING

A person or governmental entity that operates a facility at which one or more exhibitions are held is responsible for the payment of a licensing fee on behalf of the persons who do not have a State Business License but who take part in the exhibition for a purpose related to the conduct of a business.

“Exhibition” means a trade show or convention, craft show, sporting event or any other similar event involving the exhibition of property, products, goods, services, or athletic or physical skill.

**DUE DATE:** Per NRS 360.787(2)(a) - On an annual basis by remitting to the Department the sum of \$5,000 on or before July 1st for all the exhibitions held at that facility during the fiscal year beginning on that day.

Check box #1: If this is an amended return for the specified filing period, you must check this box.

Check box #2: If you are located within the Sports and Entertainment Improvement District, you must check this box.

### **CALCULATION OF AMOUNT DUE:**

Line 1: On an annual basis, you must remit to the Department the sum of \$5,000 on or before July 1, for all exhibitions to be held at the facility during that fiscal year beginning on that day.

Line 2: If this return is not submitted/postmarked and the fees are not paid on or before the due date as shown on the face of this return, a 10% penalty is owed in addition to the annual fee. Multiply Line 1 by 10% or .10.

Line 3: If this return is not submitted/postmarked and the fees are not paid on or before the due date as shown on the face of this return, interest is owed in addition to the annual fee. To calculate interest, multiply Line 1  $\times$  0.75% (or .0075) for each month, or fraction thereof, late.

Line 4: Add Lines 1 through 3 and enter the results.

Line 5: Enter the amount remitted with return.
