NEVADA TAX COMMISSION May 2, 2022

TOPIC: Review and approval of continuing need for Churchill County School District's Residential Construction Tax

AUTHORITY: NRS 387.329 – NRS 387.332

EXPLANATION: In March 2006, Churchill County School District requested a \$900 tax on residential construction be approved for levy throughout Churchill County in Accordance with NRS 387.331. The Nevada Tax Commission approved this request. The School District now has identified a continuing need to maintain and improve facilities throughout the district and is requesting a renewal of this tax at the same amount of \$900.

Based on NRS 387.332, the commission shall review the need for the continuance of the tax every four years. The last renewal was approved by the Tax Commission on May 7, 2018.

RECOMMENDATION: The school district's need to modernize and/or renovate existing buildings and grounds and to provide funding for maintenance or repair of these buildings. The continuance of the Residential Construction Tax of \$900 does not exceed the authorized tax of \$1,600 per NRS 387.331 and should be approved for another four years or until the population figures exceed 55,000, whichever occurs first. The Certified Population Estimates for FY 22/23 is 26,310.

RESOLUTION NO. 7-2022

BOARD OF CHURCHILL COUNTY COMMISSIONERS CHURCHILL COUNTY, NEVADA

A RESOLUTION IN SUPPORT OF THE CONTINUATION OF THE RESIDENTAL CONSTRUCTION TAX FOR CHURCHILL COUNTY SCHOOL DISTRICT AND OTHER MATTERS PROPERLY RELATING THERETO.

BE IT HEREBY RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS, CHURCHILL COUNTY, NEVADA:

WHEREAS, the Board of Trustees for the Churchill County School District is authorized, pursuant to NRS 387.331(2), where the population within the county does not exceed 55,000 persons, to request that the Board of County Commissioners for Churchill County, Nevada impose a tax on residential construction within the county; and

WHEREAS, the Board of Trustees for the Churchill County School District has made a request of the Board of County Commissioners for Churchill County and has provided notice of the areas of the county to be served by the residential construction tax; and

WHEREAS, the Board of County Commissioners for Churchill County has such power and jurisdiction within Churchill County, Nevada, to do and perform all such other powers as may be lawful and strictly necessary to the full discharge of the powers and jurisdiction conferred on the board; and

WHEREAS, the Churchill County Board of Commissioners approved support for the Churchill County School District's residential construction tax request on April 5, 2018, which was approved by the Nevada Tax Commission on May 7, 2018 and which became effective on the July 1, 2018; and

WHEREAS, the Board of Trustees for the Churchill County School District has determined that renewal of the residential construction tax would have, as its purpose, to assist in the cost of repairs and maintenance of current facilities, and to help provide funds for future construction and school site development. The funds derived from the tax would be placed in the school district's Capital Projects Fund restricted for the purposes provided for by law; and

WHEREAS, the Churchill County School District's Capital Improvement Plan indicates continuing maintenance needs at each facility within the Churchill County School District. This tax will help address needed maintenance on the aging school buildings in Churchill County. Timely maintenance of the existing facilities will help to extend their useful life and delay the need to build new facilities. The first priority is to maintain and improve existing facilities. Some of the planned projects include a lighting system for the High School Soccer Field, flooring replacements, fencing, sidewalk repairs, campus security cameras, roofing repairs, HVAC system replacements, and classroom technology equipment; and

WHEREAS, the district requests that the Board of County Commissioners acknowledge the need for the tax and support the Churchill County School District's application to the Nevada Tax Commission to renew the residential construction tax for at least the next four years;

NOW, THEREFORE, BE IT RESOLVED that the Churchill County Board of Commissioners, by unanimous vote, adopt this Resolution acknowledging the need for the residential construction tax and supporting the Churchill County School District's application to the Nevada Tax Commission to renew the residential construction tax for at least the next four years.

BE IT FURTHER RESOLVED that this Resolution shall be effective on the 7^{th} day of April, 2022.
