Hi Tina,

I spoke with you earlier by phone regarding the concern of the NV State Board of Dispensing Opticians (Board) related to a pending rulemaking.

I am emailing to clarify that the Board wants to have opportunity to comment on R043-24, which I believe is still in initial draft form and is not on the agenda for 5/8/24. Could you or someone from Tax let us know if that is correct re R043-24, and whether a workshop will be held at some point in the future?

We saw that a workshop (including the regulation we are looking at) was noticed last year for April 7, 2023, which would have been during the rulemaking freeze imposed under Executive Order (EO) 2023-003, but I think that may have been for the limited purpose of putting together the report required by that EO rather than serving as the workshop for R043-24 or the regulations proposed to be changed therein. That possible misunderstanding prompted the concern that the Tax Commission was adopting R043-24 without giving small business owning opticians a chance to comment.

As long as the Board and opticians generally will have the chance to comment before adoption, we are good. Please feel free to pass along to whoever it was you mentioned was your regulation guru. Thanks again for the help!
